# **EXPLORATION ACTIVITIES**

# Queensland, Australia

## Kennedy Highway Project (EPM 15948 Farm-in Agreement with Sandfire Resources NL)

Pursuant to the provisions of the Farm-in Agreement with the Company, Sandfire Resources NL (ASX:SFR) (Sandfire) has previously confirmed exercising its rights to continue with the Farm-in. This requires Sandfire to spend a minimum of \$3,000,000 in the first three years to earn 60% equity in the Kennedy Highway Project. To date Sandfire has spent more than \$1,000,000, including \$700,000 on drilling.

The agreement in place is in regard to EPM 15948. The project is located in the Eastern Succession of the Mount Isa Block, south of Cloncurry, Queensland. It is prospective for Broken Hill Type lead-zinc-silver deposits similar to BHP Billiton's high-grade Cannington mine and Iron Oxide Copper-Gold deposits similar to Glencore Xstrata's Ernest Henry Mine.

Sandfire has not reported any activities carried out during the September quarter.

## Other Tenement Areas, Queensland, Australia

No exploration activities were carried out on the remaining portfolio of tenements in Queensland.

Tenement maintenance was continued and progressed during the period, including completion of Annual Reports and or Statements of Expenditure as part of the Company's compliance with the requirements of the Department of Natural Resources and Mines.



The Company has recently lodged applications to surrender sixteen tenements and abandoned one application. Refer to the table below for further tenement details. The Company will continue to review and rationalise its tenement holdings.

As previously reported EPM 18616 was subject to a Sales Agreement with Crater Gold Mining Limited (ASX:CGN) (formerly Gold Anomaly Limited). This tenement has been granted and the documentation required to transfer the tenement has progressed. The Queensland OSR has completed its assessment and once the applicable stamp duty is paid by Crater Gold the stamped assignment form will be lodged with the Department of Natural Resources and Mines.

# **Turkey**

#### Aktarma Gold Project (100% GRM)

The Aktarma Project comprises a single Operational Licence with a ten year tenure expiring in August 2022.

No exploration activities were carried out on the Aktarma Project during the September quarter, although the Company continues assessing potential interest in the project.
